Representative Example

A mortgage of £15,160.35 payable over 15 years initially on a fixed rate for 5 years at 4.20% and then on our current variable rate of 6.87% (variable) for the remaining 10 years would require 60 monthly payments of £113.66 followed by 120 monthly payments of £128.39.
